

Parent/Student Contract

This contract is to confirm that my son or daughter, _____, will be enrolled at the Epiphany School for the 2010-2011 academic year. I understand that my failure to adhere to these terms may result in my child losing his or her placement at the school. By signing below, I am making a contract with the school and agreeing to the following terms:

I have read the policies of the Epiphany Student Handbook, and I agree to abide by them.

I agree to complete two hours of service for the school each week.

I agree to pay a \$50 deposit which I will get back after my child's graduation, provided my child returns all of his or her materials in good condition. I agree to having money withdrawn from this account when any materials are lost or damaged and paying a \$50 non-refundable re-enrollment fee every year.

I agree to attend all mandatory events such as the two progress report nights and the BBQ and Open House in the fall.

I agree to attend as many student performances, games, and parent meetings as possible.

I agree to ensure my child attends all mandatory programming – summer sessions on and off campus, the farm trip, the boat trip, and the trip to Washington, D.C., as well as required retreats and field trips.

I agree to Epiphany's suspension policy as stated in the Handbook and I agree to follow it.

I agree that my child may not bring alcohol, drugs, or weapons to the school, and I understand that doing so will result in serious disciplinary consequences.

I agree that if my child brings electronics such as cell phones and MP3 players to school, that he or she must deposit those items in his or her locker for the duration of the school day, and that if those items are brought into the school building, they will be permanently confiscated. I agree that these lockers are subject to random searches by any administrator.

I agree that I will not be late (by more than 15 minutes after dismissal) to pick up my child or other students I transport in a carpool. I agree that \$5 will be deducted from my student's deposit each time I am late to pick up my child.

I agree to find transportation for my child and anyone else I am responsible for driving if I am unable to drive on a particular day. I understand that if I drive other students home as my parent job, and my child leaves early or doesn't come to school, I am still responsible for driving the other students home or

arranging a ride for them.

I agree ensure my child remains in school for the entire day, except in the case of a valid appointment approved by the principal 24 hours in advance, with a note upon return.

I agree that seven unexcused absences will result in my child failing every class for the semester. I understand that vacations, extended absences with out a doctors note, and absences without notification are all unexcused absences.

I agree that if my child arrives at school after 7:50am without a pre-approved excuse, such as a doctor's appointment or a family obligation, my child will receive an unexcused tardy that day. I understand that unexcused tardies are equal to unexcused absence, and that a number of tardy arrivals at school that is in excess of the limit will result in my child failing all of his or her classes for the semester.

I agree to ensure that my child completes his or her homework every night and returns all books and materials to the school each day and on weekends.

I agree to ensure that my child gets adequate sleep.

I agree that my child should eat lunch and dinner each day at Epiphany. Breakfast may be eaten at home or at school.

I agree that by signing this contract, I am entering into a working partnership with the school. I agree to contact the school about any problems involving my child, or about any policies that I am temporarily having difficulty meeting.

I agree that I will do all I can to fulfill my responsibilities as an essential partner in the success of my child at Epiphany.
